

NOTIFICATION MEDCO ENERGI INTERNATIONAL SHELF-REGISTERED BONDS II 2016 PHASE II ("'SHELF-REGISTERED BONDS II PHASE II"")

THIS INFORMATION IS A NOTICE FOR ADDITIONAL INFORMATION AND/OR REVISION OF THE ABRIDGED SUPPLEMENTARY INFORMATION THAT HAS BEEN PUBLISHED IN COMPANY'S WEBSITE ON SEPTEMBER 15, 2016.

In connection with the completion of the Shelf-Registered Bonds II Phase II Public Offering, hereby notified that in accordance with the Jumbo Certificate of Shelf-Registered Bonds II Phase II, the total principal of Shelf-Registered Bonds II Phase II published on the Issue Date is amounted to Rp1,250,000,000,000 (one trillion two hundred and fifty billion Rupiah), which consists of 2 (two) series:

- A Series : A Series Shelf-Registered Bonds II Phase II having a total principal of Rp549,000,000,000.- (five hundred forty nine billion Rupiah) with a fixed interest rate of 10.8% (ten point eight percent) per annum and having a maturity of 3 (three) years from the Issue Date; The principal payment of A Series Shelf-Registered Bonds II Phase II shall be made in full on the Principal Payment Date of A Series Shelf-Registered Bonds II Phase II, which shall fall on September 30, 2019; and
- B Series : B Series Shelf-Registered Bonds II Phase II having a total principal of Rp701,000,000,000.- (seven hundred one billion Rupiah) with a fixed interest rate of 11.3% (eleven point three percent) per annum and having a maturity of 5 (five) years from the Issue Date. The principal payment of B Series Shelf-Registered Bonds II Phase II shall be made in full on the Principal Payment Date of B Series Shelf-Registered Bonds II Phase II, which shall fall on September 30, 2021.

The Shelf-Registered Bonds II Phase II shall be offered at 100% (one hundred percent) of the Principal of the Shelf-Registered Bonds II Phase II. The interest of Shelf-Registered Bonds II Phase II shall be paid every 3 (three) months in accordance with the Interest Payment Date of Shelf-Registered Bonds II Phase II, commencing on the Issue Date. The first interest payment of the Shelf-Registered Bonds II Phase II shall be made on December 30, 2016, whereas the last interest payment of Shelf-Registered Bonds II Phase II shall be made on the respective Principal Payment Date of Shelf-Registered Bonds II Phase II of each series of Shelf-Registered Bonds II Phase II. The repayment of Shelf-Registered Bonds II Phase II of Bonds II Phase II shall be paid in full (bullet payment) upon maturity.
