## FUNERAL OF THE LATE BAPAK ARIFIN PANIGORO CONDUCTED REVERENTLY

Jakarta, 8 March 2022 – The remains of the late Bapak Arifin Panigoro have been laid to rest on Tuesday, 8 March 2022 at 11:00am WIB in the family cemetery in Jakarta. The state funeral was witnessed by his extended family, colleagues, public figures, and also by his fellow Medco Group employees through live streaming.
