
Dalam rangka memenuhi Ketentuan III.3.1 dan III.3.2 Peraturan Nomor I-E PT Bursa Efek Indonesia tentang Kewajiban Penyampaian Informasi, bersama ini kami, PT Medco Energi Internasional Tbk ("Perseroan"), memberitahukan bahwa sepanjang bulan Desember 2018, Perseroan telah melakukan kegiatan eksplorasi di Blok South Sumatra PSC dan Blok Rimau PSC. Terlampir rincian kegiatan eksplorasi dari blok-blok tersebut.



LAMPIRAN I

BLOK SOUTH SUMATERA PSC DECEMBER 2018

LATAR BELAKANG

Blok South Sumatera dimiliki sepenuhnya oleh PT Medco E&P Indonesia, Blok South Sumatera ini telah menerima persetujuan perpanjangan kontrak PSC sampai dengan tahun 2033.

KEGIATAN EKSPLORASI

Kegiatan Seismik 2D

Kegiatan akuisisi seismik darat 2D berlokasi di 4 kabupaten, yaitu Kabupaten Musi Rawas, Empat Lawang, Lahat dan Muara Enim dengan total panjang lintasan 330 km. Pekerjaan ini dibagi menjadi 6 area survei, yaitu area Aini, South Sugih Waras, Kaktus – East Lily, Hijau – North Teras, Arung – Nowera, dan Rambutan Deep.

Program ini yang merupakan kelanjutan dari program sebelumnya adalah untuk mematangkan target-target dangkal di area Musi Platform yang mempunyai tingkat keberhasilan lebih baik seperti adanya temuan terbaru pada sumur Arung-1 dan Hijau-2, serta untuk mengkonfirmasi tambahan sumberdaya di prospek Rambutan Deep. Selain itu, pekerjaan ini juga sebagai pemenuhan kewajiban komitmen.

Hasil

Belum memberikan hasil.

Rencana Selanjutnya

Pelaksanaan operasi akuisisi seismik 2D direncanakan akan dimulai pada Q3 2019. Proses pengurusan izin-izin dan study lingkungan (UKL/UPL) yang diperlukan akan dilakukan sebelum pelaksanaan pekerjaan.

Biaya

Jumlah biaya kegiatan seismik sampai akhir Desember 2018 sebesar USD 38,749.

ATTACHMENT I

SOUTH SUMATERA BLOCK PSC December 2018

BACKGROUND

The South Sumatera Block PSC wholly-owned by PT Medco E&P Indonesia, this block has been awarded a PSC contract extension until the year 2033.

EXPLORATION ACTIVITIES

2D Seismic Activities

The program of 2D land seismic acquisition is located in 4 districts, Musi Rawas, Empat Lawang, Lahat and Muara Enim, with total track of 330 kms. Work sequences are divided into 6 survey areas, Aini, South Sugih Waras, Kaktus – East Lily, Hijau – North Teras, Arung – Nowera, and Rambutan Deep.

This program as the continuation of the old program is to finalize shallow targets in the Musi Platform area which has a better success rate as latest findings in Arung well-1 and Hijau-2 as well as to confirm the additional resource in Rambutan Deep prospect. Furthermore, the work is to fulfill the exploration commitment.

Results

No result yet.

Next Plan

The 2D seismic operation is planned to start in Q3 2019. The process of formalities/licenses and environmental study (UKL/UPL) required will be arranged prior to the field operation commenced.

Costs

Total seismic cost as of the end of December 2018 was USD 38,749.

LATAR BELAKANG

Blok Rimau PSC terletak di 2 Kabupaten, Musi Banyuasin dan Banyuasin, Provinsi Sumatera Selatan. RIMAU BLOCK PSC

December 2018

BACKGROUND

Rimau Block PSC is located in 2 districts, Musi Banyuasin and Banyuasin, Province of South Sumatra. The company holds 95% of Working Interest (WI), while "Perusahaan Daerah Pertambangan & Energi SUMSEL (PDPDE)" holds 5% of the Rimau Block's Working Interest. The contract is valid until 22 April 2023.

KEGIATAN EKSPLORASI

Kegiatan Study

Kegiatan Study Phase-2 berlokasi di Kabupaten Banyuasin, Sumatera Selatan. Pekerjaan ini dilaksanakan di Area Iliran High, terdiri atas 10 lubang survei dan 8 lubang fluid sampling. Kegiatan lubang survei dan testing telah selesai dilakukan pada tanggal 6 Juni 2018.

Statistik program adalah sebagai berikut :
